# INFORMATION CLAUSE

#### **Personal Data Administrator**

1. The Administrator of your personal data is Zygmunt J. Głuchowski S.C. Zygmunt Głuchowski i Helena Głuchowska Kooperacja Przemysłowo – Handlowa NIP: 6311078935, based in 44-164 Gliwice, at Łódzka 32 St represented by the Owner.

### Purposes and legal basis for data processing

- 1. Personal data are processed for the purpose of:
  - a. to exercise the rights and fulfil the obligations by the Administrator,
  - b. to perform the concluded contract,
  - c. for the purpose specified in your consent to the processing of personal data.
- 2. The basis for processing your personal data is:
  - a. article 6 section 1 item a), b), c) and article 9 section 2 item b) Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 called further RODO),
  - b. act of 10th May 2018 on the Protection of Personal Data (Journal of Laws 2018, item 1000),

### Obligation to provide data

### **Data retention period**

- 2. Personal data processed on the basis of your consent (Art. 6 par. 1, letter a) of GDPR) will be stored until it is withdrawn or for a period resulting from internal regulations.

### Personal data recipients

1. Personal data may be transferred only to the entities authorized to receive them under provisions of law or to the companies that the Administrator has concluded a personal data processing agreement.

# Rights under principles set out by GDPR

- 1. You have the right:
  - a. to access your personal data and to receive a copy thereof,
  - b. to correct, delete or limit processing of your personal data,
  - c. to object to processing,
  - d. to declare a withdrawal of any consent given at any time (the withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal),
  - e. to file a complaint with the supervisory authority, i.e. President of Personal Data Protection Office.
